SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. 7.1. Precautions for safe handling

Prevent formation of gases and vapours in flammable or explosive concentrations and concentrations exceeding the occupational exposure limits.
